A second and third meeting with each individual separately where each person could further discuss their meaning and purpose behind this decision and what this decision will mean for them and for the family they create. Finally, a meeting or series of meetings where the couple would bring together their beliefs and desires, as previously discussed under the direction of the church pastor, for a better understanding of the marriage bond and how that relates to their situation. It is at these final meetings that the actual date of the union will be set by the couple and the pastor.

The Eastern Orthodox Christian Church, N.A. Synod, does not charge a fee for any of the sacraments it is asked to give but a donation to cover the costs involved in this process toward union and to serve as a commitment on the part of the couple to complete the exchange they are requesting of the pastor is requested of the couple. This donation, \$200.00 for a simple service and \$250.00 for a service within the Divine Liturgy, is made in two payments, 50% to secure the date and commitment of the couple and 50% one week prior to the services. If extensive travel is involved, outside Harris county, travel expenses are also covered by the couple. Completion and submission of the attached application is an acceptance of the terms put forth herein.


